

## **Terms and Conditions ESMRMB Education 2021**

as per January 10, 2021

To be eligible to register for the ESMRMB 2021 educational events, you must be at least 18 years old. All time specifications for ESMRMB education refer to CET/CEST (Central European Time/Central European Summer Time). ESMRMB accepts no responsibility for errors or misprints.

### **REGISTRATION**

Registration for the ESMRMB 2021 Education events is to be made electronically by completing the respective registration form. Registrations without full name, complete email, postal address, date of birth or incorrect information cannot be processed.

### **REGISTRATION FEE**

The applicable registration fees and registration categories are shown within the corresponding (online) registration form. All prices for the ESMRMB 2021 Education events are indicated excl. VAT and no VAT will be charged

### **SPECIAL REGISTRATION FEES FOR ESMRMB MEMBERS**

Special registration fees are available for members in good standing who have paid their 2021 membership fee. Reduced or free of charge registration is only provided if the registered person confirms being an active member of the society and upon confirming to have paid the appropriate membership fees.

Members who are not confirmed due to missing documents, despite having paid the membership fee, are not recognised as active members and will not be granted special/reduced member fees.

### **PAYMENT**

Payment of registration fee can be made by credit card (VISA or MasterCard). Payment by bank transfer, cheque or in any other way is not accepted.

### **CANCELLATION/REFUND**

In case of cancellation, ESMRMB will not refund any registration fee(s).

### **CANCELLATION, POSTPONEMENT, RELOCATION**

In the event that it is judged advisable or necessary to have any ESMRMB education event cancelled or postponed (e.g. natural disasters, epidemics, official orders etc.), ESMRMB shall not be obliged to any refunds.

### **NAME CHANGES**

Name changes will be treated like the cancellation of one registration and the new registration of another participant. New registration and payment are required.

### **LIMITATION OF LIABILITY**

There is neither any liability nor any obligation of ESMRMB in case of cancellation of any education event for whatever reasons. ESMRMB shall not be liable for any damages caused by force majeure or any other reason.

### **PLACE OF PERFORMANCE/APPLICABLE LAW/PLACE OF JURISDICTION**

The place of performance of any duties and obligations for ESMRMB Education 2021 and the participant sides shall be Vienna, Austria.

Any contractual relationship with ESMRMB Education 2021 shall be subject to Austrian law.

Place of jurisdiction shall be 1010 Vienna, Austria. ESMRMB shall also be entitled to pursue any claim before the courts of law competent for the defendant's domicile or general residence.
