

Terms & Conditions of Members of the European Society for Magnetic Resonance in Medicine and Biology (ESMRMB) for 2019

As per December 2018

ORDINARY MEMBERS

Regular Membership Fee €175

Regular Member

Benefits: access to the Online Journal MAGMA, reduced fees for annual scientific meetings and educational activities of the ESMRMB, access to the online membership directory and Society minutes and documents.

Reduced Membership Fee €25

Junior Member

Criteria: Junior membership is limited to 6 years following the date of the last diploma (bachelor, masters, medical degree). A copy of the diploma (bachelor, masters, medical degree) has to be uploaded during online application or sent to the ESMRMB Office no later than 10 days after membership application in order to validate your membership. Please note that this does not apply for PhD degrees.

Benefits: access to the Online Journal MAGMA, reduced fees for annual scientific meetings and educational activities of the ESMRMB, access to the online membership directory and Society minutes and documents.

Radiographer Member

Criteria: Applicant needs to be working as MR radiographer/technologist. They are requested to provide an attestation from the head of the institution/head of department no later than 10 days after membership application. The attestation needs to be current (i.e. from 2019) and should state clearly that the applicant is working as MR radiographer or technologist at the indicated institution/department.

Benefits: access to the Online Journal MAGMA, reduced fees for annual scientific meetings and educational activities of ESMRMB, access to the online membership directory and Society minutes and documents.

Senior Member

Criteria: minimum 5 years of full membership in the ESMRMB, certification of retirement (copy to be sent to the ESMRMB Office at the latest 10 days after application for Senior Membership), age above 60 years (copy of passport to be sent to the ESMRMB Office at the latest 10 days after application for Senior Membership)

Benefits: access to the Online Journal MAGMA, reduced fees for annual scientific meetings and educational activities of the ESMRMB, access to the online membership directory and Society minutes and documents.

ASSOCIATE MEMBERS

Associate Member (€25)

Criteria: Applicant needs to be member of a national society, which is a partner society of the ESMRMB.

Benefits: access to the Online Journal MAGMA, information on society news

Free Associate Member (€0)

Criteria: Applicant needs to be member of a national society, which is a partner society of the ESMRMB.

Benefits: information on society news

VALIDATION OF MEMBERSHIP

After receipt of full payment of the membership fee you are a member in good standing until the end of the calendar year 2019.

RIGHTS AND DUTIES OF MEMBERS

Members in good standing shall be entitled to participate in all events of the Society and to use the facilities of the Society. Corporate members shall have the right to nominate three persons as ordinary members who shall be accepted according to the conditions laid down for the class of membership concerned. Partner Societies and associated members shall only be entitled to receipt of the Society's regular information material. Associate members may have online access to the official society journal MAGMA upon payment of a pre-defined fee. Upon decision of the Executive Board, associate members may become entitled to participate in events of the Society at a reduced registration fee and to use the facilities of the Society, subject to the conditions decided by the Executive Board.

Ordinary members in good standing and honorary members shall have the right to vote and to elect officers. The right to stand for elections, however, shall be reserved for ordinary and honorary members who have their place of residence in Europe.

Members shall be obliged to further the interests of the Society as far as their resources permit it and to refrain from activities that could harm the image and purpose of the Society. Members are to observe the statutes of the Society as well as the decisions taken by the bodies of the Society. Both ordinary and corporate members shall be obliged to pay the membership dues in the amount determined by the Annual Business Meeting in time.

TERMS OF TERMINATION OF MEMBERSHIP

Membership shall expire through death (in the case of corporations, companies or other organizations including commercial enterprises through the loss of their legal personality), voluntary withdrawal, cancellation or exclusion.

VOLUNTARY WITHDRAWAL

Voluntary withdrawal shall be possible at any time. It is to be notified to the Executive Board at the address of the ESMRMB office (office@esmrm.org) in writing at least 1 month prior to the end of the calendar year, preceding the year in which the withdrawal shall become effective. If the notification occurs late, the withdrawal shall become effective at the next withdrawal date, which is the end of the calendar year following the notification of withdrawal.

CANCELLATION

Cancellation of membership may be decided by the Executive Board if the member is, despite two written reminders, more than two months in arrears with the payment of his/her membership dues. The annual membership fee shall be paid until the end of the current year. Cancellation shall not affect the member's obligation to pay the unsettled dues of the current year.

EXCLUSION

Exclusion from the Society may be decreed by the Executive Board on grounds of a serious violation of membership obligations or of dishonourable conduct. Appeal to the Business Meeting against exclusion shall be possible. The membership rights shall be suspended until a decision is taken by the Business Meeting.

WITHDRAWAL OF HONORARY MEMBERSHIP

Withdrawal of honorary membership may be decided by the Business Meeting upon request by the Executive Board.
